"MB Audio-conference 7 April 2009 10. WP7 and Tas4.2 overlap issue

The overlap between task 4.2 (in WP4) and WP7 was acknowledged. Following a specific discussion on the activity "Liaising with EU Member State RFID initiatives", it was decided to integrate task 4.2 within the WP7 activities, under AIDC responsibility, and to invite participants to task 4.2 to contribute to WP7 activities. The decision on whether a specific contract amendment is necessary or if a gentleman agreement can be found to leave task 4.2 in WP4 will have to be taken, taking into consideration that ETSI will continue to liaise with EU Member State RFID initiatives as part of their activities in WP4."
